Reading/ correction and approval of the minutes from the last meeting- (need to approve the May minutes due to being updated)

Reports of officers, boards, and standing committees-

1. Officers

- a. President
 - Interpreters, inclusion/accessibility policy working to put this policy in place and receive requests, currently using it for interpreters, fundraising for use for interpreter requests
 - ii. Background check policy any flagged policy comes back to the commissioner to make the argument about why we should make an exception, the board can then hear the arguments to make a decision
 - 1. background check is a final vetting check, commissioners should know their coaches and parents around the children Maryland case search is publicly available for commissioners and coaches to use
 - 2. if a check comes back yellow, we can ask the person if they would like to provide information that can be brought back to the board for review, but we cannot ask for specifics

 - iv. Coaches committee addendum voted in years ago, but not in our documents
 - 1. Clint will work on revising/editing this along with the by-laws
 - v. URC AED purchasing, fundraising
 - 1. FCPR facilities have them in them; Lacrosse, football and wrestling have their own
 - 2. All in favor of purchasing 2 AEDs for all sports to utilize; cannot advertise we will have one present at all events, but we can utilize it if needed
 - vi. URC emergency action plan/first aid training
