 - d. Urbana youth basketball and the Mid-maryland basketball league Brook Aranda request via email
 - i. Brook Aranda, Vitto Cresta, Andrew Murphy, and Casey Marshall were present to discuss concerns within the youth basketball and Mid-Maryland programs.

- ii. Leadership should prioritize player development, feel the environment we have now is causing us to lose kids to other programs and leave the community at both the youth and high school level.
- iii. The league is not developmentally appropriate at 6U, all in house league rules do not lend themselves to teaching them skills appropriate for the next level
- iv. The 5/6 and JV teams both won their championships at the mid-maryland level, concerns about transitioning to varsity with the current coach kids are afraid, have heard negative reports. Questions about how coaches are chosen, what is the process, it seems that they stay the same from year to year and parents would like to understand how coaches are picked.
- v. 70 athletes from Urbana (4th rising 8th graders) participate in Hoopology, have left the URC program due to a variety of reasons.
- vi. Top 3 items that need to change: program board within basketball, coaches interviews, re-evaluate rules at younger age groups.
- vii. Due to Joe's recent medical crisis, the board will advertise the basketball commissioner position on social media starting Monday, 8/18. Nominations will be taken for one week via email to the URC secretary. An open meeting via Google Meet will be held Monday, 8/25 @ 9pm to vote on a new commissioner. The URC ECB will review the votes and appoint a new basketball commissioner no later than Wednesday, 8/27.
